How to open the portal in Digital Traffic Lok Adalat?

- ❖ Go to the Digital Traffic Lok Adalat Court Portal URL: <https://traffic.delhipolice.gov.in/lokadalat/#/>
- ❖ Enter the vehicle number
- ❖ Enter the Captcha
- ❖ OTP will be sent on vehicle owner registered mobile number.

- ❖ To access the Digital Traffic Lok Adalat Court portal, the mobile number must be registered with the corresponding vehicle details. If the mobile number is not registered, a registration prompt will appear. To complete the registration, click on the “**Update Vehicle Owner Mobile Number**” button provided on the Home page. Once registration is completed, challans and notices can be downloaded from the Digital Traffic Lok Adalat Court portal by entering the required parameters.



- ❖ After successful OTP verification, the pending challans and notices will be displayed. The individual must then select the relevant challans/notices, the court complex (subject to the availability of courts/benches), and a suitable time slot to book an appointment for settlement of the challans/notices in the Lok Adalat. The individual is required to take a printout of the appointment details before appearing in the court.

Process for Booking an Appointment in the Digital Traffic Lok Adalat

- An individual may print a maximum of **five notices and two challans** for a **private vehicle**, and a maximum of **one notice and one challan** for a **commercial vehicle**. The total number of available slots across different court complexes will be displayed on the screen.
- Select the **nearest court complex** from the available options.
- Choose a **convenient time slot**, either **Forenoon** or **Afternoon**.
- Carefully read and check the undertaking: *“I will not contest the challan on the Virtual Court portal, i.e., vcourts.gov.in.”*
- Click on the **“Submit”** button to proceed.
- After successful submission, the **“Print”** button will appear on the screen.
- Click on the **“Print”** button to print the pending challans and notices for presentation before the court.

Note:-

- Printing of challans/notices for commercial vehicles shall be permitted only in cases where the fine amount is less than **₹10,000**.
- Disposal shall be allowed only for **compoundable challans/notices**.
