WHEREAS it is necessary to ensure the smooth
flow of traffic and safety of road users on Pusa Road
from Rajouri Garden to Shanti Park;

AND WHEREAS the provision of sufficient traffic

and the need has arisen to prohibit and ban the use of motor vehicles
including two-wheeler, three-wheeler and four-wheeler vehicles from
driving on Pusa Road during the hours of
10:00 AM to 11:00 PM.
