Keeping in view the difficulties of General public due to implementation of one way traffic circulation system and to facilitate the entry of goods vehicles in Naya Bazar during the non-restricted hours, it is considered necessary to modify the restriction of Heavy Goods Vehicles and Medium Goods Vehicles on Mori Gate Road (Sl.No.45 of Notification issued vide No.8160-8359/TE Br. (D.II), dated 2.7.96), Shayma Prashed Mukherjee Marg (Sl. No.8 of Notification issued vide number 7960-8159/TE Br. (D.II) dated 2.7.96) and Pul Dufferin.

Now, therefore, I, M.S. Upadhye, Deputy Commissioner of Police, Traffic, Delhi in exercise of powers conferred upon me under Regulation 30(1) of Delhi Control of Vehicular and other Traffic on Road and Streets Regulation 1980 do hereby prohibit the plying & idle parking of Heavy Goods Vehicles and Medium Goods Vehicles during peak hours from 7.30 A.M. to 11.00 A.M. and between 5.00 F.M. to 9.30 P.M. of the day on Mori Gate Road (instead of 24 hours restrictions as notified earlier vide Sl.No. 45 of Notification issued vide No.8160-0359/TE Br. (D.II), dated 2.7.96), Shayma Prashad Mukherjee Marg between Pul Dufferin South and Pili Kothi, -Naya Bazar, -Pul Mithai and Pul Dufferin.

Regarding restriction on other stretch(es) of Shayma Prashad Mukherjee Marg i.e. from Pul Dufferin to Calcuttia Cate the notification No.7960-8159/TE Br. (D.II), dated 2.7.96 will continue to remain in force.

This order shall be published for the information of the general public in the official (azette and by affixing a copy on notice boards of the offices of all Districts/Units DCsP and all Police Stations, Police Posts and other offices of Delhi Police in the Delhi/New Delhi area.

The concerned givic agency and road maintaining authorities shall remove/srect the corresponding sign boards indicating the restriction on Mori Gate Road as mentioned above for the information and convenience of all concerned.
