NOTIFICATION

Whereas it is necessary to ensure the smooth flow of traffic and safety of road users on Chhota Bazar (Shahdara).

And whereas the problem of congestion/traffic holds up on Chhota Bazar (Shahdara) due to the movement of Heavy Goods vehicles/Medium Good Vehicles and Light Good Vehicles has assumed serious proportions and is endangering the life of road users:

Now, therefore, I, Arvind Deep, Dy. Commissioner of Police, Traffic, Delhi in exercise of the power conferred upon me under regulation 30(1) of the Delhi control of vehicular and other traffic on road and street regulation 1980 do hereby prohibit the plying of Heavy Goods Vehicles/Medium Good Vehicles and Light Good Vehicles on Chhota Bazar (Shahdara) from 8.00 A.M. to 8.00 P.M.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the Notice Boards of the offices of all Distt. DCSP and all Police Stations in Delhi/New Delhi.

The concerned civic agency and road maintaining authorities shall erect corresponding sign boards indicating the restrictions in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.
