## ORDER

Whereas it is necessary to ensure smooth flow of traffic and safety of road users on Mehrauli-Gurgaon Road, Anuvrat Marg and Aurvindo Marg (from IIT flyover to Anuvrat Marg).

And whereas in view of this problem of congestion on Mehrauli-Gurgaon Road, Amyrraf Marg and Aurvindo Marg(from IIT flyover to Amyrrat Marg), it is necessary to regulate the movement of traffic on the above road for the convenience of road users.

Now, therefore, I Satish Golohha, Dy. Commissioner of Police, Traffic, Delhi in exercise of the power conferred upon me under regulation 30(1) of the Delhi Control of Vehicular and other Traffic on Roads and Street Regulations, 1980 do hereby prohibit the plying of HGVs and LGVs and MGVs on Mehrauli-Gurgaon Road, Anuvrat Marg and Aurvindo Marg(from IIT flyover to Anuvrat Marg during peak hours from 0730 hours to 1100 hours & 1700 to 2130 hours.

This order shall be published for information of the general public in the official gazette and by affixing a copy on the Notice Boards of the offices of all Distt. DCsP and all Police Stations in Delhi/New Delhi.

The concerned civic agency and road maintaining authority shall crect corresponding sign boards indicating the restriction in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.
