NOTIFICATION

Whereas it is necessary to ensure smooth flow of traffic and safety of road users on the following roads and entry points in Sainik Farms areas.

And whereas in view of this problem of congestion it is necessary to regulate the movement of traffic on the following roads and entry points in Sainik Farm areas for the convenience of road users.

Now, therefore, I, Mukesh Kumar Meena, Dy. Commissioner of Police, Traffic, Delhi in exercise of the power conferred upon me under regulation 30(i) of the Delhi Control of Vehicular and other Traffic on Road and Streets Regulation, 1980 do hereby prohibit the plying of HGVs / MGVs and LGVs carrying building materials on the following roads and entry points in Sainik Farms area for 24 hours.
