**NOTIFICATION**

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of Heavy and medium goods vehicles, which cause traffic problems and congestion and also endanger the life of other road users on Roshanara Road, Rani Jhansi Road and Boulevard Road.

An whereas in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on above roads for the convenience of road users and the safety of other road users.

Now, therefore, I, M.K. Meena, Deputy Commissioner of Police, Traffic (Hdqs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980" do hereby prohibit the plying and idle parking of heavy and medium goods vehicles for 24 hours of the day on Roshanara Road, Rani Jhansi Road and Boulevard Road, till further orders. This order will suppress the earlier notifications/orders issued by Deputy Commissioner of Police, Traffic, Delhi regarding plying and idle parking of heavy and medium goods vehicles on Roshanara Road, Rani Jhansi Road and Boulevard Road.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with effect from 10-12-2004.
