NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of LGVs, which cause traffic problem and congestion and also endanger the life of other road users on Prithvi Raj Road from Aurbindo Chowk to South End Road.

And whereas in view of this problem of congestion, it is necessary to regulate the movement of traffic on above road for the convenience of road users and the safety of pedestrians.

Now, therefore, I. Mukesh Kumar Meena, Dv. Commissioner of Police, Traffic, Hdgrs, Delhi in exercise of the power conferred upon me under regulation 30 (i) of the Delhi Control of Vehicular and other Traffic on Road and Streets Regulation, 1980 do hereby prohibit the plying and idle parking of LGVs for 24 hours of the day on Prithvi Raj Road from Aurbindo Chowk to South End Road, Delhi, till further orders.

This order shall be published for information of the general public in the official gazette and by affixing a copy on the Notice Boards of the offices of all Dist. DCsP and all Police Stations in Delhi New Delhi.

The concerned civic agency and road maintaining authority shall erect corresponding sign boards indicating the restriction in the area for the information and convenience of all concerned.

This order shall come into force with effect from 24+3-2005
