## NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of Medium & Light goods vehicles, which cause traffic problems and congestion and also endanger the life of other road users from the following entry points towards Connaught Place.

And whereas in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on the following roads for the convenience of road users and the safety of other road users.

Now, therefore, I, Mahabir Singh, Deputy Commissioner of Police, Traffic (Hdqrs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980" do hereby prohibit the plying and idle parking of MGVs & LGVs from 9 AM to 9 PM on the following entry points towards Connaught Place, till further orders.

- 1. From Bangla Sahib Road/ Panchkuian Road Crossing towards Connaught Place.
- 2. From Gole Dak Khana/ Baba Kharak Singh Marg towards Connaught Place.
- 3. From Minto Road /DDU Marg crossing towards Connaught Place.
- 4. From Round About Mandi House/Bara Khamba Road towards Connaught Place.
- 5. From Basant Road/ Chelmsford Road crossing towards Connaught Place.
- 6. From Tolstoy/ Janpath crossing towards Connaught Place.
- 7. From Tolstoy /Sansad Marg crossing towards Connaught Place.
- 8. From Tolstoy/ K.G. Marg crossing towards Connaught Place.
- 9. From Tolstoy/ B.K. Road crossing towards Connaught Place.
- 10. Under Maharaja Ranjeet Singh Flyover towards Connaught Place.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.
