whereas it is necessary to ensure the smooth flow of traffic and the safety of road users on Ch. Harsukh Marg;

and whereas the problem of congestion/traffic jam at Ch. Harsukh Marg due to the movement of Heavy and Medium Goods Vehicles has assumed serious proportions and is endangering the life of road users;

Now, therefore, I, Ujjwal Mishra, Deputy Commissioner of Police, Delhi in exercise of powers conferred upon me under Regulation 30(1) of the Delhi Control of Vehicular and other Traffic on Roads & Streets' Regulations, 1980 do hereby prohibit the plying of heavy and medium goods vehicles on Ch. Harsukh Marg during the entire day i.e., from 7.30 A.M. to 9.30 P.M.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the offices of all Distt. Deputy Commissioners of Police and all police stations in Delhi/New Delhi.

The concerned civil agency and road maintaining authorities shall erect the corresponding sign boards indicating the restriction in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.
