NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of heavy goods vehicles with trailers and semi-trailers carrying containers, which cause traffic problems and congestion and also endanger the life of other road users on Delhi Roads.

And whereas in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on Delhi roads for the convenience of road users and the safety of other road users.

Now, therefore, I, D.P. Verma, Deputy Commissioner of Police, Traffic (Hdqs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980" do hereby prohibit the plying and idle parking of all type of trailers and semi-trailers carrying container entering from neighbouring States on all roads of Delhi except that they can enter and exit Delhi via Badarpur Border and follow Mathura Road-Mehrauli/Badarpur Road-ICD Tuglakabad. The time restrictions applicable to the movement of heavy goods vehicles in Delhi will also be applicable to trailers/semi-trailers carrying container.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
