NOTIFICATION

Whereas, the movement of Light Goods Vehicles on Mehrauli - Badarpur Road (from 'T' point Anuvrat Marg upto Khanpur 'T' Point) is causing congestion and problem in smooth flow of traffic and also endangering the life of motorists and other road users.

And whereas in view of the above mentioned problems, it is necessary to regulate the movement of goods vehicles on Mehrauli – Badarpur Road (from T point Anuvrat Marg upto Khanpur 'T' Point), to ensure free flow of traffic and safety of motorist and other road users.

Now, therefore, I, Prabhakar, Deputy Commissioner of Police, Traffic (HQ) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980 do hereby prohibit the plying of Light Goods Vehicles on Mehrauli – Badarpur Road (from 'T' point Anuvrat Marg upto Khanpur 'T' Point) from 8.00 AM to 11.00 AM and from 5.00 PM to 9.00 PM.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
