Now, therefore, I, Prabhakar Deputy Commissioner of Police, Traffic (HQ) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980 do hereby prohibit the plying of Heavy, Medium and Light Goods Vehicles on IGNOU Road (from 'T' Point M.B. Road to Indira Gandhi National Open University/Maidan Garhi) from 7.00 AM to 11.00 PM for HGVs and MGVs and from 8.00 AM to 11.00 AM and from 5.00 PM to 9.00 PM for Light Goods Vehicles.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
