## NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of HGVs/MGVs/LGVs, which cause congestion and also endanger the life of other road users on main roads going inside Sangam Vihar from Mehrauli-Badarpur Road.

And whereas in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on above roads for the convenience of road users and the safety of other road users.

Now, therefore, I, Prabhakar, Deputy Commissioner of Police, Traffic (Hdors.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980" do hereby prohibit the plying and idle parking of Heavy, Medium and Light Goods Vehicles during peak hours i.e. from 8.00 AM to 11.00 AM and from 5.00 PM to 9.00 PM on main roads going inside Sangam Vihar from Mehrauli-Badarpur Road, till further orders.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioners of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
