## NOTIFICATION

Whereas, there have been frequent instances and complaints of traffic congestion caused by the movement of heavy and medium goods vehicles in the NCT of Delhi and whereas in view of the ongoing preparations for the Republic Day -2013 in the National capital, it is necessary to ensure smooth flow of traffic and prevent congestion besides inconvenience to motorists and other road users on account of movement of heavy and medium goods vehicles which cause congestion and also endanger the life and safety of other road users particularly on National Highway No. 8, National Highway No.24, Grand Trunk Road (Shahdara) and Wazirabad Road.

And whereas in view of the problems of traffic congestion on these important highways and arterial roads it is necessary to regulate the movement of traffic in larger public interest, maintenance of public order and for the convenience and safety of all road users on these roads.

Now, therefore, I, Sharat Kumar Sinha, Deputy Commissioner of Police, Traffic (Hdqrs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and other Traffic on Roads and Streets Regulation, 1980" do hereby prohibit the entry, plying and idle parking of Heavy and Medium Goods Vehicles during peak hours from 7.00 AM to 11.00 AM and 5.00 PM to 10.00 PM till 31st January, 2013 instead of earlier peak hours i.e. 7.30 AM to 11.00 AM and 5.00 PM to 9.30 PM on the following mentioned roads:-

S. No.	Name of the Road
1.	NH-8 from Rajokri Border upto Dhaula Kuan
2.	NH-24 from Gazipur Border upto Akshardham Temple Flyover.
3.	GT Road Shahdara from Apsara Border upto ISBT Kashmere Gate.
4.	Wazirabad Road from Bhopra Border upto Wazirabad 'T' Point.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office off all Deputy Commissioners of Police/Districts and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect and remain in force till 31st January, 2013.
