The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect and remain in force till 22<sup>nd</sup> February, 2013.

## **NOTIFICATION**

Whereas, there have been frequent Instances and complaints of traffic congestion caused by the movement of heavy and medium goods vehicles on Noida Toll Road and whereas in view of the ongoing civil works on Kalindi Kunj Barrage and congestion on Mahatma Gandhi Marg near Ashram, it is necessary to ensure smooth flow of traffic and prevent congestion besides inconvenience to motorists and other road users on account of movement of heavy and medium goods vehicles on carriageway leading traffic from Noida Toll Gate to Mahatma Gandhi Marg near Ashram which cause congestion and also endanger the life and safety of other road users.

And whereas in view of the problems of traffic congestion on Noida Toll Road on the carriageway leading traffic from Noida Toll Gate to Mahatma Gandhi Marg (M.G. Road) near Ashram, it is necessary to regulate the movement of traffic in larger public interest, maintenance of public order and for the convenience and safety of all road users on Noida Toll Road on the carriageway leading traffic from Noida Toll Gate to Mahatma Gandhi Marg near Ashram.

Now, therefore, I, Sharat Kumar Sinha, Deputy Commissioner of Police, Traffic (Hdqrs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulation, 1980" do hereby prohibit the entry, plying and idle parking of Heavy and Medium Goods Vehicles on Noida Toll Road on the carriageway leading traffic from Noida Toll Gate to Mahatma Gandhi Marg near Ashram during day time i.e. from 7:00 AM to 10:00 PM till 22<sup>nd</sup> February, 2013.
