### NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users due to the movement of HGVs/MGVs/LGVs, which cause congestion and also endanger the life of other road users on the roads of Dwarka Sub-City.

And, whereas, in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on the roads of Dwarka Sub-City for the convenience and safety of road users and larger public interest.

Now, therefore, I, Rupinder Kumar, Deputy Commissioner of Police, Traffic (Hdqrs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulation, 1980" do hereby prohibit the entry, plying and idle parking of Heavy, Medium and Light Goods Vehicles during peak hours i.e. from 7.00 AM to 11:00 AM and 5:00 PM to 10:00 PM on the following roads:-

S.No.	Name of Road / Stretch
1.	Road No. 201, from Palam Flyover to Dwarka More (Kakrola More).
2.	Road No. 202, from Dada Dev Mela Ground to Sector 13/14 Crossing, Dwarka.
3.	Road No. 205, Sector-22 Crossing Dwarka to Judicial Academy, Dwarka.
4.	Road No. 208, from Sector-21, Metro Station Dwarka to Police Station Dwarka North.
5.	Drain Road, from Dabri Crossing to Madhu Vihar Crossing Dwarka.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioners of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
