NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and inconvenience to motorists and other road users on Asaf Ali Road from Hamdard Chowk to Turkman Gate.

And whereas in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic on above road for the convenience of road users and the safety of other road users.

Now, therefore, I, R.K. Jha, Deputy Commissioner of Police, Traffic, Headquarters, Delhi in exercise of the powers, conferred upon me under Regulation 21 of the Delhi Control of Vehicular and Other Traffic on Roads and Street Regulations, 1980 do hereby declare the stretch of Asaf Ali Road from Hamdard Chowk to Turkman Gate "One way" for all type of vehicles till further orders.

This prohibitory order will apply throughout the day i.e. 24 hours of everyday.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding informatory signboards indicating the restrictions in the area for the guidance and convenience of all concerned.

This order shall come into force with immediate effect.
