## NOTIFICATION

Whereas, it is necessary to ensure smooth flow of traffic and prevent congestion and to avoid inconvenience to motorists & other road users in Chandni Chowk area and in view of undergoing redevelopment work on Chandni Chowk Road.

And whereas, in view of the problem of traffic congestion, it is necessary to regulate the movement of traffic in Chandni Chowk area for the convenience of road users and the safety of other road users.

Now, therefore, I, R.K. Jha, Deputy Commissioner of Police, Traffic, Headquarters, Delhi in exercise of the powers, conferred upon me under Regulation 21 of the Delhi Control of Vehicular and Other Traffic on Roads and Street Regulations, 1980 do hereby declare the following "One way" traffic circulation plan for all type of vehicles till further orders:-

- 1. Traffic will move in one-way direction from Red Fort Chowk to Fatehpuri Masjid on the Southern Carriageway.
- 2. Traffic coming from Khari Baoli would compulsorily take left turn at Khari Baoli Church Mission T-Point and would exit towards Shayam Prasad Mukherjee Marg.
- 3. Traffic coming from the direction of Katra Bariyan, would not be allowed to turn right at Fatehpuri Masjid. This traffic will go straight towards Church Mission Road and turn left for Khari Baoli or go straight towards Shyama Prasad Mukherjee Marg for Town Hall or Chandni Chowk.
- 4. There would be no U-Turn for Buses/HTV/MGV/LGV at the cut on central verge near Bankhandi on Shyama Prasad Mukherjee Marg.
- For the traffic coming on Shyama Prasad Mukherjee Marg from the direction of Peeli Kothi towards Old Delhi Railway Station, there would be "No Right Turn" at the T-Point of Shyama Prasad Mukherjee Marg – Church Mission Road.
- 6. Church Mission road would be one way from Fatehpuri Masjid Chowk towards Shyama Prasad Mukherjee Marg. Traffic would be discharged from Fatehpuri Masjid towards Shyama Prasad Mukherjee Marg or Khari Baoli via Church Mission Road and no traffic would be allowed to enter Church Mission Road from the direction of Shyama Prasad Mukherjee Marg.

In addition there will also be not stopping, waiting, loading and unloading in the southern carriageway of Chandni Chowk Road for any class of vehicle including cycle rickshaw, hand drawn carts etc.

This prohibitory order will apply throughout the day i.e. 24 hours of everyday.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding informatory signboards indicating the restrictions in the area for the guidance and convenience of all concerned.

This order shall come into force with immediate effect.
