regarding pollution in Delhi.**

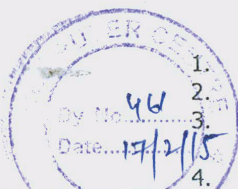
Reference this office U.O. No. 165-240/Legal Cell/Traffic, dated 28.01.2015() and No. 434-510/Legal Cell/Traffic, dated 4.2.2015, on the subject cited above. The Hon'ble National Green Tribunal order dated 19.01.2015 regarding unauthorised parking in the markets of Lajpat Nagar & Karol Bagh is enclosed. In the above matter the following orders of Special C.P./Traffic, Delhi were conveyed to all concerned for strict compliance :-

1. To start the fixation of 'No Parking" boards on the roads.
2. Request North DMC to issue public advertisement and Announcements.
3. Start major prosecution and removal of vehicles.
4. Inform about the prosecuting amount in 'No Parking zones".
5. Upload the cancellation of parking orders in Karol Bagh on website and also add on social media, 1095, Mobile App etc.
6. Put as many boards as possible about cancellation of parking from our side also with 1095 helpline No. displayed on it.
7. Increase prosecution with proper documentation so as to be able to use the data in NGT Reply.

TI/Karol Bagh and TI/Lajpat Nagar may be directed to ensure the compliance of Hon'ble NGT order dated 19.01.2015. Both the TIs may be directed to contact Shri D. Rajeshwar Rao, Govt. Counsel (mobile No. 9811013123, 9868285051) alongwith action taken report and get the para-wise reply affidavit prepared on behalf of Delhi Traffic Police so that Govt. Counsel may file the reply before Hon'ble Green Tribunal, New Delhi well before the next date of hearing i.e. 25.02.2015. A compliance report in this regard may please be sent to this office by **23.2.2015** well before the next date of hearing fixed for **25.02.2015** in order to avoid any adverse view of the Hon'ble Green Tribunal, New Delhi.
