

**NOTIFICATION**

Whereas, the movement of goods vehicles on GTB Hospital Road, Road between Dilshad Colony and Dilshad Garden residential area & Loni Road in Seema Puri Circle is causing traffic congestion and endangering the life of motorists and other road users.

And whereas, it is necessary to regulate the movement of traffic on the above mentioned roads to ensure smooth flow of traffic and for convenience and safety of motorists and other road users.

Now, therefore, I, R.K. Jha, Deputy Commissioner of Police, Traffic (Hdqs.) Delhi in exercise of the powers conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulation, 1980" do hereby prohibit the entry, plying and idle parking of goods vehicles on the following road and road/stretches in Seema Puri Circle:-

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioners of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road maintaining agencies shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
