Delhi in exercise of the powers conferred upon me under Section 3 of the "Delhi Control of Vehicular and other traffic on Roads and Streets Regulation, 1980" do hereby order that the service road alongwith Badarpur Road near Meetha Pur/Jait Pur Mor, Delhi shall be used as a TSR stand for halting and parking of 5 TSRs at a time with the condition that the notifying authority reserves the right to cancel the notification subsequently in the public interest. No Pucca/Semi Pucca structure, water, electricity and telephone connection shall be allowed on the

This order shall come into force with immediate effect.

This order will be published for the information of the general public through press, affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding signboards indicating the "Halt and Go Places for TSR" in the area for the information and convenience of all concerned.
