NOTIFICATION

Whereas, restriction on plying and idle parking of HGVs & MGVs was imposed on various roads/road stretches of Delhi including Old Rohtak Road from Usha Mata Mandir, Sarai Basti upto Azad Market for 24 hours of the day vide Notification No. 4867-5057/TE(D-II)/Traffic dated 06.06.2006.

And whereas, difficulties are being faced by the suppliers in smooth supplying of essential commodities at Kishanganj Malgodam, Northern Railways.

And whereas, it is necessary to revise the present restriction timing imposed on plying and idle parking of HGVs and MGVs on Old Rohtak Road from Kishanganj Malgodam to Y-Point Kishanganj to ensure smooth supply of essential commodities to and fro Kishanganj Madgodam, Northern Railways as well as to ensure smooth and safe flow of traffic in the area.

Now, therefore, I, Manoj C., Deputy Commissioner of Police/Traffic (TE), Delhi in exercise of the powers, conferred upon me under regulation 30(1) of the "Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulation, 1980" do hereby revise the present restriction timing imposed on plying and idle parking of HGVs and MGVs on Old Rohtak Road from Kishanganj Malgodam to Y-Point Kishanganj from 24 hours of the day to peak hours i.e. 7.00AM to 11.00AM and 5.00PM to 9.00PM, till further orders.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding informatory signboards indicating the restrictions in the area for the guidance and convenience of all concerned.

This order shall come into force with immediate effect.
