NOTIFICATION

Whereas, the movement of HGVs, MGVs and LGVs on Bhati Mines Road (SSN Marg) from 100 Foota road red light (Anuvrat Marg) to Sanjay Colony, Bhati Mines is causing obstruction in smooth flow of traffic and inconvenience to other road users.

And whereas, it is necessary to regulate the movement of traffic on the above mentioned road to ensure smooth flow of traffic and for convenience and safety of motorists and other road users.

Now, therefore, I, Aslam Khan, Deputy Commissioner of Police/Traffic (HQ), Delhi in exercise of the powers, conferred upon me under regulation 30(1) of "The Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulations, 1980" as amendment vide notification No. 03/Spl. Cell/PHQ dated 03.01.1997, do hereby prohibit the entry, plying and idle parking of HGVs, MGVs and LGVs (excluding 3-wheeled light goods vehicles) on Bhati Mines Road (SSN Marg) from 100 Foota road red light (Anuvrat Marg) to Sanjay Colony, Bhati Mines from 07.00 AM to 11.00 PM, till further orders.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding informatory signboards indicating the restrictions in the area for the guidance and convenience of all concerned.

This order shall come into force with immediate effect.

And whereas, it is necessary to regulate the movement of traffic in Lajpat Nagar Traffic Circle to ensure safe & smooth flow of traffic and for convenience of motorists and other road users.

Now, therefore, I, Aslam Khan, Deputy Commissioner of Police/Traffic (HQ), Delhi in exercise of the powers, conferred upon me under regulation 30(1) of "The Delhi Control of Vehicular and Other Traffic on Roads and Streets Regulations, 1980" as amendment vide notification No. 03/Spl. Cell/PHQ dated 03.01.1997, do hereby prohibit the entry, plying and idle parking of HGVs, MGVs and LGVs (excluding 3-wheeled light goods vehicles) on the following roads in Lajpat Nagar Traffic Circle:-

This notification supersedes the earlier Notification issued by this office vide No. 145-295/TE(D-II)/Traffic dated 09.01.2014 regarding prohibition on plying and idle parking of HGVs, MGVs and LGVs on Hospital Road.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioners of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road maintaining agencies shall erect the corresponding signboards indicating the restrictions in the area for information and convenience of all concerned.

This order shall come into force with immediate effect.
