

NOTIFICATION

Whereas, on Bunglow Road, Kamla Nagar heavy flow of traffic is causing obstruction in smooth & safe flow of traffic and inconvenience to motorists and other road users;

And whereas, it is necessary to regulate the movement of traffic on Bunglow Road, Kamla Nagar to ensure smooth & safe flow of traffic and for convenience of motorists and other road users;

Now, therefore, I, Aslam Khan, Deputy Commissioner of Police/Traffic (HQ), Delhi in exercise of the powers, conferred upon me under Regulation 21 of the Delhi Control of Vehicular and Other Traffic on Roads and Street Regulations, 1980 do hereby declare Bunglow Road, Kamla Nagar 'One Way' for all type of vehicles from Round About Roop Nagar to Hansraj College T-Point from 9.00 AM to 9.00 PM everyday, till further orders.

This order shall be published for information of the general public in the official gazette and by affixing a copy on the notice boards of the office of all District Deputy Commissioner of Police and all Police Stations in Delhi/New Delhi.

The concerned civic road agencies maintaining the roads/areas shall erect the corresponding informatory signboards indicating the restrictions in the area for guidance and convenience of all concerned.

This order shall come into force with immediate effect.
