CIRCULAR

Subject: - Implementation of Notification No. S.O. 1522 (E) dated 06.04.2018 of Ministry of Road Transport & Highways, GOI.

Delhi Traffic Police has notified maximum speed limits for different categories of motor vehicles on various roads/road stretches in the NCT of Delhi under Regulation 9(1) of Delhi Control of Vehicular and Other Traffic on Roads and Street Regulation, 1980 (framed u/s 28 Delhi Police Act, 1978). Copies of the notifications dated 29.08.2011 and 22.02.2017 are enclosed herewith for ready reference. It is bring to the notice of all the field functionaries that Ministry of Road Transport & Highways, Govt. of India vide Notification No. S.O. 1522 (E) dated 06.04.2018 has clarified that "No cognizance of the violation of the speed limits shall be taken under section 183 of the Motor Vehicles Act, 1988, if the speed limit is within 5 per cent of the maximum speed specified in the notification."

All DCsP/T-Ranges/ACsP/Traffic Distts. and TIs/Circles are hereby directed to brief their prosecuting officers not to take cognizance of the violation of overspeeding u/s 183 of the Motor Vehicles Act, 1988, if the speed detected is within 5 per cent of the maximum speed notified for the different categories of motor vehicles under the above referred notifications. All the supervisory officers shall ensure necessary compliance on ground so that these instructions are implemented in true letter and spirit by all concerned.

NOTIFICATION

Whereas, unregulated plying of motor vehicles on a high speed on the roads of NCT of Delhi is endangering the life of motorists as well as other road users/commuters.

And whereas, it is necessary to regulate the speed of motor vehicles on the roads of NCT of Delhi for safety of motorists as well as other road users/commuters.

Now, therefore, I, Sharat Kumar Sinha, Deputy Commissioner of Police, Traffic, Headquarters, Delhi in exercise of the powers, conferred upon me under regulation 9 (1) of Delhi Control of Vehicular and Other Traffic on Roads and Street Regulations, 1980 do hereby declare the maximum speed limit of motor vehicles as mentioned below for the areas/roads specified: -
