CIRCULAR

Subject:- Regarding – Free passage to emergency vehicles.

In-continuation to the instructions issued vide this office No. 5167-5241/TE(D-II)/Traffic dated 29.08.2014 regarding free passage to emergency vehicles. The Transport Department, GNCT of Delhi has issued a notification u/s 115 for providing free passage to emergency vehicles vide No. F.19(95)/Tpt./Sectt./2010/54 dated 04.03.2014 (copy enclosed) in-continuation to their earlier notification issued vide No. F.19(95)/Tpt./Sectt./2010/04 dated 20.04.2011 (copy enclosed). This notification was issued with an objective to ensure interrupted movement of emergency vehicles such as Ambulances, Fire Engines, Police Patrol Vans in the interest of safety of the general public in Delhi/New Delhi areas. As per this notification the extreme right lane on roads having three or more lanes will be used by these emergency vehicles while they are attending emergent situations in the NCT of Delhi. These emergency vehicles when using the extreme right hand lanes in emergency indicated by a siren and flashing of lights will have the overriding right of way over all other motorized traffic. All other categories of vehicles shall vacate the extreme right lane by moving to the left of the road/street. The violators of the notification issued u/s 115 of Motor Vehicles Act, 1988 are liable to be punished under section 194(1) of Motor Vehicles Act, 1988 attracting a penalty of Rs. 2000/- at the spot. Officers of the rank of ASIs and above of Delhi Traffic Police are empowered to prosecute the violators and compound the offence at the spot.

In order to ensure that the emergency vehicles viz. Ambulances, Fire Engines etc., move uninterruptedly while attending emergent situations in the NCT of Delhi, it is important to sensitize all the enforcement officers regarding the above mentioned notifications and clear passage is provided to these emergency vehicles when they are proceeding to attend any emergent situation on Delhi roads.

All DCsP/Traffic-Ranges, ACsP/Traffic-Districts and Tls/Circles are hereby directed to brief the enforcement officers working under their

operational control accordingly to implement and enforce the notification in true letter and spirit. All officers are also directed to coordinate with other agencies for better implementation on ground.

The violators of section 115 of Motor Vehicles Act, 1988 are liable to be punished under section 194(1) of Motor Vehicles Act, 1988. All the challans in this respect should be forwarded to the concerned courts for taking cognizance since the powers to compound the offence under section 194(1) of Motor Vehicles Act, 1988 is not vested with the officials of Delhi Traffic Police.

All ACsP/T-Districts and Tls/Circles are hereby directed to brief the enforcement officers working under their operational control accordingly to implement and enforce the notification in true letter and spirit.

NOTIFICATION

Whereas, it has been observed that emergency vehicles such as Fire Brigade vehicles. Ambulances, Police Patrol Vans and vehicles of transport Department, Government of NCI of Delhi are not being provided free passage by other categories of motor vehicles while these emergency vehicles are being driven to prevent damage to the public or to attend to any emergency situation(s).

Whereas it is imperative for these emergency vehicles to reach their destination in time in the interest of public order, safety and security and to ensure free passage to these emergency vehicles.

Therefore, in exercise of the power conterred by section 115 read with clause (41) of section 2 of the Motor Vehicles Act 1988, (59 of 1988), the Lieutenant Governor of the National Capital Territory of Delhi, on being satisfied that it is necessary to ensure the uninterrupted movement of Emergency Vehicles such as Ambulances, Fire Engines Police Patrol Vans and vehicles of Transport Department. Government of NCT of Delhi and in the interest of safety of the general public in Delhi/New Delhi areas, does hereby, order that the extreme right lane on roads having three or more fanes will be used by emergency vehicles like Fire Brigades.

Antibulances PCR Vans of Vehicles of Transport Department, Government of NCT of Delhi while they are attending emergencies. These emergency vehicles when using the extreme right of way. All other categories of vehicles will vacate the extreme right lane by moving to the left of the road/street.

This notification shall be valid till March 31. 2012.
