Subject:- Extension of the validity of documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 and further to consider relaxation in Permit – fee / taxes etc. **(upto 31.10.2021 & 30.11.2021)**

In continuation to this office U.O. Nos. 1445-65/TE (D-I)/Traffic dated 31.03.2020, 2365-70/TE (D-I)/Traffic dated 15.07.2020, 4271-4296/TE(D-I)/Traffic dated 15.09.2020, 166-195/TE(D-I)/Traffic dated 11.01.2021, 2109-2126/TE (D-I)/Traffic dated 05.04.2021 and 3761-3792/TE(D-I)/Traffic 18.06.2021 on the subject cited above.

**Ministry of Road Transport and Highways, GOI** vide its letter No. RT-11036/35/2020-MVL dated 30.09.2021 has issued advisory the States/UTs that the documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 viz **Fitness, Permit (all types), Driving License, Registration or any other concerned documents** whose extension of validity could not, or was not likely be, granted due to lock-down and which had expired since 01.02.2020 or would expire by 31.10.2021, the same may be treated as valid till 31.10.2021. Enforcement authorities are advised to treat such documents **valid till 31<sup>st</sup> October, 2021.**

Similarly, **Transport Deptt., Govt. of NCT of Delhi** vide its order dated 28.09.2021 **has extended the validity of the transport documents issued by Transport Deptt., GNCT of Delhi** which have expired/expiring between 01.02.2020 to 30.09.2021 for two months i.e. **upto 30.11.2021.** However, the vehicles plying on road should have a valid PUC to ensure pollution control.

Copies of the above cited letter and order are enclosed herewith, which is self-explanatory, for your kind information and necessary action accordingly.

**Subject: Extension of the validity of documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 and further to consider relaxation in Permit - fees / taxes etc.**

Madam / Sir,

Please refer to the order by Ministry of Home Affairs vide No.40-3/2020-DMI(A), dated 24th March 2020, and the guidelines issued subsequently, pursuant to a decision to impose a complete lock down in view of the threat imposed by the spread of COVID-19. The Government has provided for the availability of the essential goods and production thereof and has allowed the vehicles for the transport of such goods / cargo and further opened up the operation of passenger transport. It had come to the notice of the Government that citizens were facing difficulties in renewal of validity of various documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 due to lock-down being at various stages in the country, and were expected to face long queues in front of Government Transport Offices.

2. In view of the above, Ministry of Road Transport and Highways had issued advisories dated 30th March, 2020, 9<sup>th</sup> June, 2020, 24<sup>th</sup> August 2020, 27<sup>th</sup> December 2020, 26<sup>th</sup> March, 2021 and 17<sup>th</sup> June, 2021 to all States and Union Territories regarding extension of validity of the documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989. It was advised that the validity of Fitness, Permit (all types), Driving License, Registration or any other concerned document(s) whose extension of validity could not be, or was not likely to be, granted due to lock-down and which had expired since 1st of Feb, 2020, or would expire by 30th of September, 2021, the same may be treated to be valid till 30th of September, 2021. Enforcement authorities were advised to treat such documents valid till 30th of September, 2021.

3. Taking into consideration the grim situation still continuing due to conditions for prevention of spread of COVID-19 across the country, it is advised that the validity of all of the above referred Documents whose extension of validity could not be, or was not likely to be, granted due to lock-down and which had expired since 1st of Feb, 2020 or would expire by 31<sup>st</sup> October, 2021, the same may be treated to be valid till 31<sup>st</sup> October, 2021. Enforcement authorities are advised to treat such documents valid till 31<sup>st</sup> October, 2021. This will help citizens in availing transport related services.

4. All the States and Union Territories are requested to implement this advisory in letter and spirit so that citizens, transporters, and various other organizations which are operating under this difficult time may not get harassed and face difficulties.

**ORDER**

**Subject: Extension of the validity of documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989**

Ministry of Road Transport and Highways had issued advisories dated 30.03.2020, 09.6.2020, 24.8.2020, 27.12.2020, 26.3.2021 and 17.06.2021 to all States and Union Territories regarding extension of validity of the documents related to Motor Vehicles Act, 1988 and Central Motor Vehicles Rules, 1989. It was advised that in case of Fitness, Permit (all types), Driving License, Registration or any other concerned document(s) whose extension of validity could not or was not likely be granted due to lock-down and which had expired since 01.02.2020 or would expire by 30.09.2021, the same may be treated to be valid till 30.9.2021. Enforcement authorities were advised to treat such documents valid till 30.09.2021.

Information has been received from various field offices that a large number of applicants are turning up for various services as the validity of various documents is going to expire on 30.9.2021.

Instances of heavy crowding at various driving license centres have also been reported which is a matter of concern for the health and safety of applicants as well as the staff delivering the public services.

It is also noted that due to prolonged period of lockdown during the last one and a half year period, there has been a cascading impact on the essential activities, leading to congestion, crowding and delay in various services including services of Transport Department.

Even though, the situation has become almost normal but adequate precautionary steps are required to be taken to avoid recurrence of Covid Pandemic like situation and for that reason, the validity of documents issued by Transport Department, which expired between 1.2.2020 to 30.9.2021 is further extended for two months i.e. upto 30.11.2021.

The vehicles plying on road should have a valid Certificate of PUC to ensure pollution control.

This issues with the approval of Hon'ble Minister (Transport).
