Advisory on extension of the Validity of documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 under the period of prevention of Covid-19.

In continuation to this office U.O. No. 1445-65/TE (D-I)/Traffic dated 31.03.2020, U.O No. 2365-70/TE (D-I)/Traffic dated 15.07.2020 and U.O No. 4271-4296/TE(D-I)/Traffic dated 15.09.2020 on the subject cited above. Ministry of Road Transport and Highways had issued an advisory dated 30th March, 2020 to all states and Union Territories regarding extension of validity of the documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989. It was advised that validity of Fitness, permit (all types), Driving License, Registration or any other concerned document(s) whose extension of validity could not or not likely be granted due to lock-down and which had expired since 1st of Feb, 2020 or will be expire by 31st of March, 2021, the same may be treated to be valid till 31st of March, 2021. Enforcement authorities were advised to treat such documents valid till 31st of March, 2021. Vide letter No. RT-11036/35/2020-MVL Government of India Ministry of Road Transport & Highways dated 27th December, 2020. A copy of the above cited letter is enclosed herewith, which is self explanatory, for your kind information and necessary action accordingly.

Subject: Extension of the Validity of documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989

Madam /Sir,

Please refer to Ministry of Home Affairs Order No. 40-3/2020-DMI(A), dated 24th March 2020, and the guidelines issued subsequently, pursuant to a decision to impose a complete lock down initially and certain restrictions subsequently in view of the threat imposed by the spread of COVID-19. The Government has provided for the availability of the essential goods and production thereof and has allowed the vehicles for the transport of such goods / cargo and further opening up the operation of passenger transport In view of the fact that citizens were finding it difficult to get renewed the validity of various documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989 due to lock-down in operation at various stages in different parts of the country and other countries world over. Renewal of such documents is still leading to assembly of people and long queues in front of the Transport Offices across the country.

- 2. In view of the above, Ministry of Road Transport and Highways had issued advisories dated 30th March, 2020, 9th June, 2020 and 24th August 2020 to all States and Union Territories regarding extension of validity of the documents related to Motor Vehicles Act, 1988 and Central Motor Vehicle Rules, 1989. It was advised that the validity of Fitness, Permit (all types), Driving License, Registration or any other concerned document(s) whose extension of validity could not or not likely be granted due to lock-down and which had expired since 1st of Feb, 2020, or would expire by 31st of December 2020 the same might be treated as valid till 31st of December 2020. Enforcement authorities were advised to treat such documents as valid till 31st of December 2020.
- 3. Considering the Pandemic situation is yet to become normal and Government needs to bring conducive situation for prevention of spread of COVID-19 across the country, it is advised that the validity of all the of the above referred Documents whose extension of validity could not or not likely to be granted due to COVID -19 pandemic and which is expired from 1st of Feb, 2020 or would expire by 31st March 2021, be treated as valid till 31st March 2021. Enforcement authorities are advised to treat such documents as valid till 31st March 2021. This will help out the citizens in availing transport related services.

4. All the States and Union Territories are requested to implement this advisory in letter and spirit so that the citizens, the transporters and various other organizations which are operating under this difficult time during Covid Pandemic may not get harassed or face difficulties.
